1. The Non-Load-Bearing Principle

By definition, a curtain wall does not carry any dead load from the building other than its own dead load weight. 2. The Rain Screen Principle and Pressure Equalization

Technical Analysis of Curtain Wall Systems

Comparison of Primary Curtain Wall Typologies

Engineering and Mathematical Considerations

Curtain wall design is governed by strict mathematical limits on deflection. According to **AAMA CWDG1-96**, the maximum allowable deflection for a glass-supporting member is typically limited to **$L/175$** (where L is the clear span) or a maximum of 3/4 of an inch (19mm). For spans exceeding 13.5 feet, the formula often shifts to **$L/240 + 1/4$** " to ensure that the glass does not pop out of the glazing pocket or experience excessive stress that could lead to spontaneous breakage.

Material Specifications and Finishes

The **Aluminum Technical Specifications** provided by AAMA define the chemical and physical properties required for architectural-grade extrusions. Most systems utilize **6063-T5 or 6063-T6 aluminum alloys**, known for their excellent extrudability and strength-to-weight ratio.

Surface Finishes: AAMA 2603, 2604, and 2605

Selecting the right finish is paramount for longevity, especially in coastal or high-pollution environments. AAMA categorizes organic coatings based on their performance:

- AAMA 2603: Pigmented organic coatings for interior or low-exposure residential use.
- AAMA 2604: High-performance coatings for commercial use, offering 5 years of South Florida weathering resistance.
- AAMA 2605: The "Superior" standard, requiring 10 years of South Florida weathering and 70% PVDF (Fluoropolymer) resin for maximum UV and chemical resistance.

Step-by-Step Installation Workflow (Based on AAMA CWG-1)

1. Substrate Verification: Before installation, the concrete or steel structure must be surveyed. Benchmarks and offset lines are established to ensure the curtain wall is perfectly plumb and level.
2. Anchor Installation: Structural anchors (fixed and expansion types) are secured to the building slabs. These must be engineered to handle the calculated wind and dead loads.
3. Frame Assembly (Stick System): Vertical mullions are installed first, followed by horizontal transoms. It is critical that water dams and sealants are applied at the intersections of these members to prevent internal leaks.
4. Glazing: Glass units are set onto setting blocks. Depending on the design, this may be a dry-glazing system

(using EPDM gaskets) or a wet-glazing system (using structural silicone).

5. Pressure Plate and Cover Installation: In captured systems, pressure plates are screwed into the mullions at specific torque intervals to ensure uniform compression of the gaskets.

6. Perimeter Sealing: The gap between the curtain wall and the building structure is filled with backer rods and sealant to create an airtight and watertight seal.

Testing and Validation Protocols

A curtain wall system is only as good as its tested performance. The **AAMA 501 series** provides the testing procedures used to validate performance in specialized labs or on-site.

AAMA 501.1: Dynamic Water Penetration

Unlike static tests, this test uses a large aircraft engine or a massive fan to create high-velocity wind while spraying water onto the system. This simulates the conditions of a hurricane to ensure that wind-driven rain cannot bypass the internal drainage systems.

AAMA 501.2: Field Hose Testing

This is a quality assurance test performed on-site. A calibrated nozzle is used to apply a specific water pressure to joints and seams. It is a vital step for identifying installation errors before the building is occupied.

AAMA 501.4 and 501.7: Seismic and Inter-story Drift

In seismic zones, the curtain wall must be able to sway with the building. These tests evaluate the system's ability to maintain structural integrity and glass retention when the building frame undergoes lateral displacement.

Field Guide: Troubleshooting Common Failure Modes

Even with high-quality manuals like **AAMA CWM-19**, field failures can occur. Understanding these issues is key to effective building maintenance.

1. Water Infiltration at the Base

- Performance Class: Specify whether the system should meet AW (Architectural Window) or CW (Curtain Wall) ratings.

- Water Resistance: 15 psf or 20% of the design wind load, whichever is greater.
- Thermal Requirements: Specify U-factors and Solar Heat Gain Coefficients (SHGC) that align with local energy codes (e.g., ASHRAE 90.1).
